Grievance Redressal Timeline:

- Receipt of Grievance: Immediate acknowledgement within 2 working days
- > Initial Review: 3 working days by designated committee
- Resolution: 7 working days from receipt of grievance
- > Appeal: 5 working days to file an appeal against resolution
- Final Decision: 10 working days from appeal receipt
